Supervisor Rice called the Regular Board Meeting to order at 6:30pm with the Piedge of Allegiance.

PUBLIC HEARING OPENED AT 6:30PM ON PROPOSED LOCAL LAW 1-2019, A LOCAL LAW TO REQUIRE PRIOR WRITTEN NOTICE AS A CONDITION PRECEDENT TO THE MAINTENENANCE OF A CAUSE OF ACTION AGAINST THE TOWN OF STRATFORD, NEW YORK, and OVERRIDING LOCAL LAW 1-1980

Supervisor Rice stated that NYMIR suggested that Stratford update Local Law 1-1980. NYMIR provided a sample copy, which was reviewed by Attorney Macri, and Town Clerk VanDenburgh posted public hearing notices on the StratfordNY.com website, Stratford Facebook page, public boards outside of her office and transfer station, along with notices printed in the official town newspapers on June 3rd, 2019. Supervisor Rice asked those in attendance if they had any comments, and besides clarifying what the law was, no person in attendance objected to the updated law. PUBLIC HEARING CLOSED AT 6:37PM

RESOLUTION 18-19: TO ADOPT NEW LOCAL LAW 1-2019, A LOCAL LAW TO REQUIRE PRIOR WRITTEN NOTICE AS A CONDITION PRECEDENT TO THE MAINTENENANCE OF A CAUSE OF ACTION AGAINST THE TOWN OF STRATFORD, NEW YORK, and OVERRIDING LOCAL LAW 1-1980

WHEREAS, the Town of Stratford enacted Local Law 1-1980, a local law to require prior written notice as a condition precedent to the maintenance of a cause of action against the Town of Stratford, New York, and

WHEREAS, Local Law 1-1980 was recently reviewed by and considered insufficient by New York Municipal Insurance Reciprocal (NYMIR), and

WHEREAS, under NYMIR's recommendation, an updated law was presented to the Stratford Town Board for review to override Local Law 1-1980 and public notices presented to the public;

RESOLVED, the Town Board of the Town of Stratford agrees to adopt new Local Law 1-2019, a Local Law which requires prior notice of defect as a condition precedent to the maintenance of a cause of action against the Town of Stratford, New York, and Overriding Local Law 1-1980 ("Prior Notice of Defect Law overriding Local Law 1-1980")

Correspondence: CDPHP RATE HIKE REQUEST: CDPHP is proposing a 1.4% premium rate change.

Reports:

Highway Superintendent Goodwin's report was reviewed by the Town Board (See attached). A tire flew off their 2014 Freightliner and hit a car in a resident's parked car. They investigating the nut/hub assembly and the damage from the accident is going through town insurance. Supt. Goodwin stated that Hanson's quoted him \$84,000 for Stewart Landing and \$105,000 for West Shore Road. He is looking to begin that work after Labor Day. Super. Rice passed out an invoice from Tom's Electric, showing that the repairs/upgrades recommended by NYMIR for the Highway Dept. fuel shed had been completed on Tuesday. The highway dept. wood boiler was listed on the auction website, but the highest bid was, almost \$4,000 short of the minimum acceptable bid. Supt. Goodwin declined the bid, and a discussion was had on whether to advertise it on Facebook/Craigslist. He will also check on the warranty of the new truck being purchased by the town. Super. Rice will email the purchase contract to Board Members Fogarty, Ploss, and Rumrill and will work on the purchase contract next week. Attorney Macri is reviewing it.

BRIDGE ON PISECO ROAD: Engineer Bell sent a letter to NYSDOT stating that the bridge in question did not need posting or flagging, stating "... we believe this bridge no longer needs to be posted for load, and the Town of Stratford can remove the 8 Ton posting signs." We are awaiting their response.

KEYBANK CONTRACT: Super. Rice discussed the purchase agreement of the new Mack Granite 64FR plow truck. Supt. Goodwin will check on the warranty of the new truck being purchased by the town. Super. Rice will email the purchase contract to Board Members Fogarty, Ploss, and Rumrill and will work on the purchase contract next week. Attorney Macri is reviewing it. Since the Keybank contract is time-sensitive, a special meeting might be needed to complete the purchase agreement before the next meeting.

Code Enforcement Officer Wright read his report to the Town Board (See attached).

There was no Assessor report for this month.

<u>DCO Jaquay's report was reviewed by the Town Board</u> (See attached). Super. Rice reminded the public that you need a kennel license if you own more than five dogs, and that residents should report any questionable dog activity to DCO Jaquay or CEO Wright when it comes to buildings.

<u>BTI Director Sokira read his report to the Town Board</u> (See attached). He stated "Bugs are bad," and that many other towns are having a similar issue. Unfortunately, the creeks couldn't be reached early enough to treat due to snow/ice. He discussed proposed DEC changes to pesticide regulations that will financially impact the town should they be adopted. BTI Director Sokira left at 7:10pm.

<u>Stratford Historian Marshall:</u> Historian Marshall requested that Donna Hasbrouck be appointed her Deputy Historian so Ms. Hasbrouck would have the same access that Ms. Marshall has to historian-only meetings. There will be no salary or cost to the town.

RESOLUTION 19-19, THE APPOINTMENT OF DONNA HASBROUCK AS DEPUTY HISTORIAN

BE IT RESOLVED that Donna Hasbrouck has been appointed Deputy Historian to Moira Marshall,

FURTHERMORE, this position shall be a volunteer position with no compensation or reimbursement from the Town of Stratford.

Justice Arena's report for this month was reviewed by the Town Board (See attached). He collected \$300 in fines for the month of May. He gave Super. Rice a check on June 4th for the Town's portion.

The Town Clerk's report for this month was reviewed by the Town Board (See attached). A discussion was had about a complaint sent to Super. Rice regarding a Salisbury resident who was upset about being denied a transfer station permit. Super. Rice stated that although their zip code was Stratford, their residence was the Town of Salisbury and paid taxes to Herkimer County. TC VanDenburgh emphasized that you must be both a Fulton County and Town of Stratford resident in order to qualify for a transfer station permit.

<u>Supervisor's Report:</u> Super. Rice thanked all who attended the public hearing on the school budget. She reminded those in attendance about the budget vote on June 18th. She stated that Stratford is looking at decreased revenues in 2020; we anticipated this and our budget for 2019 will probably break even this year, but we will have to lower our anticipated revenue for 2020.

CONTRACT WITH HIGHWAY DEPARTMENT: All Board Members received a copy of the Memorandum of Agreement between Stratford and the United Public Service Employees Union (UPSEU).

A motion to go into Executive Session for Contract Negotiations was made at 7:25pm by Councilwoman Rumrill, seconded by Councilwoman Ploss.

Financial Report:

Stratford's equalization rate is down to 97% (from 100%). Super. Rice presented the financial spreadsheets/reconciliation and bank statements to the Board Members. She is still visiting Senator Tedisco's office and inquiring on the grant to repair the Highway Department. There is new leadership, so the grant process has stalled.

June 13, 2019 Town Clerk Regular Meeting Report

- Attached to this report is my semi-annual Town Clerk's report for Board review.
- The Town Clerk's office has migrated to the Electronic Death Registry System (EDRS). Fulton
 County was part of the spring 2019 rollout. The Registrer can now process death certificates
 electronically, in compliance with NYS Public Health Law \$4148.
- Supervisor Rice received a complaint about my office via email from a resident of Salisbury on June 4th 2019. I had to unfortunately deny this person a transfer station decal due to their residency being the Town of Salisbury. Although their nalling address is Stratford, their actual residence is taxed and lies in Herkimer County. This person has received a transfer station detal for the last 10 years, and was upset that they were denied this year. She made a complaint about my behavior, and asked Supervisor Rice to reconsider issuing her a decal. As I stated to Supervisor Rice, there is no easy way to tell someone that they do not qualify for a permit, and many Salisbury residents have been angry at my decision. I'd like to reiterate again that you must the in the Town of Stratford and pay taxes to Fulton County in order to qualify for a transfer residen decision.
- A gentieman who has a seasonal residence on Stewart Landing was recently told by Verizon that
 they are no longer issuing new home numbers in our area and refused to install a copper phone
 line to his camp. I am currently looking into this.
