Supervisor Rice called the Regular Board Meeting to order at 6:30pm with the Pledge of Allegiance.

Reality Check: youth action component of the Bureau of Tobacco Control Presentation

Rachel Johnson introduced the Board to the local Reality Check group and explained its origins. It is an adult-mentored, youth-led, anti-tobacco group with the aim to educate and prevent youth tobacco use. The rise in e-cigarette and flavored vaping products aimed at children has caused the incidence of tobacco use in younger people to rise. Three of their youth members (Alexis, Trisha, and Will) spoke and explained their reasons for involvement, and the positive changes they've made in the Dolgeville/Manheim communities such as helping the townships pass meaningful policies that prevent more tobacco retailers from entering the community and reducing the use of tobacco advertisements aimed at underage children. Reality Check asked if the Stratford Board would consider similar policies within their township and offered help crafting them to meet the needs of our community. They passed out pamphlets to share with the public. The Board and public held a Q&A with Reality Check about tobacco use in Dolgeville Central School. DCS is considering vape detectors, and the highest risks for vaping/tobacco use are students between 7-9th grade. The presentation was concluded and the Board thanked Reality Check for their insight. They left at 6:57pm.

Stratford Volunteer Fire Department Budget Presentation

Chief Vedder read a statement to the Board, and stated that currently the SVFD has 15 members, with 4 of them being interior firefighters. Due to the ambulance issues in Stratford, the SVFD now answers every EMS call, as they are all CPR/AED certified. They are looking into a first responder's course as well. They are first on scene when electric poles and trees are down. They are requesting a \$10,000 a year budget increase, from \$60,000 to \$70,000. They would like to lock this increase in a 3-year contract instead of yearly, preventing them from requesting an increase for 3 years. They explained the reports they gave the Board members, and the equipments requirements they must adhere to per NYS. Councilwoman Rumrill

asked them if they have appealed to the Stratford public with a donation letter to raise funds. She also asked for a simple monthly report the Board could review that lists how many calls and reasons for those calls. Councilman Fogarty asked if the Board could vote on the SVFD budget request on Monday, October 14th during the budget meeting. All agreed.

NO CORRESPONDANCE.

Highway Superintendent Goodwin's report was reviewed by the Town Board (See attached) A daily inspection sheet for the highway trucks was provided by Super. Goodwin. The new truck delivery is scheduled for October 24th, and the closing at the bank will be on Friday, October 25th. The total cost of the truck is \$238,179.00, and will be funded by a 5-year loan at 2.8% through Adirondack Bank. Utica Mack will be paid this month for the base truck, and Tracy Road Equipment will be paid when the attachments (plow) are installed. Council. Fogarty asked about the tree in the park. Hwy. employee Ben R. damaged his chainsaw when he attempted to cut it down. The tree had been filled with concrete. He asked Super. Rice if the Board would consider accepted \$700 for the highway log splitter instead of \$800 for the damages to his chainsaw. Council. Fogarty asked if we could get quotes for a company to grind out the stump.

RESOLUTION 28-19 Change of Terms of Sale of Highway Department Wood Splitter

RESOLVED that the Stratford Town Board agrees to change the purchase terms of Resolution 26-19, to sell Ben Rutkowski the Highway Department wood splitter for the purchase price of \$700.00 rather than the previously agreed price of \$800.00.

<u>Code Enforcement Officer Wright's report was reviewed by the Town Board</u> (See attached). He stated it has been a very busy month. Council. Fogarty asked about the Plac property on State Route 29A. He asked why the CEO Wright hasn't followed up on the resolution guidelines regarding the safety fencing around the property. CEO Wright stated that he has to notify Mr. Plac that the fence fell and he was no longer in compliance. After a discussion, it was decided that Mr. Plac had enough warnings about the condition of the property and Super. Rice said CEO Wright needs to ticket him.

<u>Dog Control Officer Jaquay's report was reviewed by the Town Board</u> (See attached). There was a question whether DCO Jaquay could send a ticket in the mail to avoid confrontation with the accused. The Board was fine with her sending tickets as long as a return receipt was requested to ensure proof of delivery.

Town Historian Moira Marshall verbally conveyed her report this month. She and Deputy Historian Hasbrouck took an archiving course in Cooperstown. She stated that they need a formal policy about acceptance of historical records when they are donated to the Town, so it is clear who owns the record.

Justice Arena's report for this month was reviewed by the Town Board.

Town Clerk VanDenburgh verbally conveyed her report this month. TC VanDenburgh helped order and set up the new Assessor computer. She had to make an emergency purchase of a new office monitor when hers would no longer turn on. She also got a quote on new CEO quadruplicate forms (Application for Construction Inspection) when CEO Wright notified her that his forms were no longer transferring the writing to the duplicates. Unfortunately, she could not find the original voucher for when these forms were purchased, indicating that they are most likely a decade old, and would not be under warranty. She also stated that after many months of going over our gigabyte limit on our Viasat internet plan, she called up Viasat to see what plans are available for the Town offices. She upgraded the plan usage from 10 GB to 12gb per month with no price increase. The next plan option offered is \$84.95/month for 40 GB of usage per month, if the Board wishes to consider it.

Councilman Perkins made a motion to increase the internet package. This motion was rescinded.

<u>Supervisor's Report:</u> Super. Rice reports that there were 6 applicants for the position of Sole Assessor, and 5 were interviewed. One was allowed to answer questions via email. The Board unanimously agreed to appoint David Galarneau as Stratford's Sole Assessor. He has maintained the Town of Bleecker at 100% equalization rate for the past 16 years, has all the qualifications necessary, and has a good track record of working with communities.
