Supervisor VanDenburgh called the regular meeting to order at 6:00 p.m. with the Pledge to the Flag.

CORRESPONDENCE: None

REPORTS:

Highway Dept.: Highway Superintendent Staring reported that the reprofiling and chip sealing on Seeley, Piseco and Powerhouse roads has been completed with the assistance of crews and trucks from Oppenheim, Ephratah, Johnstown and Salisbury. Stratford crews assisted in Oppenheim and Salisbury.

One drainage pipe on Mallett Hill Road that failed has been replaced, but there is another that also needs to be replaced. The Irish Settlement Road bridge has been repaired and the red flag from the state should be removed as soon as all the paperwork is completed.

The Ford and the Mack are back in service. The Ford had problems with the DEF system and Mack had the transmission and clutch replaced under warranty.

The FEMA calls continue. He is still awaiting the final design for Vorhees Road. There has been a price increase on the state contract price for the pipe sections and connecting bands needed to complete the Vorhees Road project. The state price has risen from \$21,775.07 to \$48,756.55, but the new price is considerably lower than the current retail price.

A motion by Supervisor VanDenburgh, seconded Councilwoman Ploss, to approve the purchase of the drain pipes under the state contract price was approved unanimously:

The superintendent also reported that the price for sand will be \$3.25/yard this year and the town will need 4,000 yards at a cost of \$13,000. A motion by Councilwoman Rumrill to approve the purchase of the sand, seconded by Supervisor VanDenburgh, was approved unanimously.

Town Assessor: The Town Supervisor reported the town assessor had been out of town for most of the month. Councilwoman Rutkowski reported she attended the public meeting he had held on Sept. 3 for residents with questions or concerns about tax assessments and was pleased with the way the assessor had conducted the session

Dog Control Officer: The town supervisor reported that the DCO had issued two tickets for failure to license dogs during the past month.

BTI Director: Since the season had concluded there was nothing to report.

Town Justice: Judge Rissmeyer submitted a copy of his monthly report to the State Comptroller's office.

Town Historian: She reported she will attend the Historian Convention in Oswego on Sept. 13-15. She said she is exploring what the Stratford Historical Society needs to do to become a non-profit organization. She said that would open the possibility of obtaining grants and other services available to non-profits. She said the Historical Society will meet on Sept. 27 at 6:30 p.m. and will be presenting a slide show of old photos of Stratford. Anyone interested is encouraged to attend

Town Clerk: Clerk reported has appointed Christopher Tesi who recently relocated to Stratford as his deputy clerk.
