SECTION 1: TITLE

This local law shall be known and may be cited at Local Law No. 1 of the Year 1997 Regulating Animals on Property in the Town of Stratford.

SECTION 2: DEFINITIONS

For the purpose of this local law animals shall mean any and all of the following: pigs, cows, horses, ponies and chickens.

Property means any private dwelling, house, building or other structure whether occupied or temporarily or continuously occupied or vacant and shall include any yard, grounds, walk, driveway, road, parking area, porch, steps, vestibule or mailbox belonging or pertinent to a private dwelling, house, building or other structure in the Town of Stratford.

SECTION 3: LEGISLATIVE INTENT

It is the purpose of this local law to preserve and promote the health, safety and general welfare of the inhabitants of the Town of Stratford.

SECTION 4: ANIMALS

A. No person, partnership, association or corporation being the owner or occupant of any land within the Town of Stratford shall use or allow the use of such land for animals without appropriate housing and proper containment of said animals.

B. Animals will be subject to such other regulations as the Town Board may prescribe by general order or rule and to any conditions that the Board may impose.

SECTION 5: RULES AND REGULATIONS

A. The town board is hereby empowered to make and promulgate, from time to time and by order or resolution, such rules and regulations relating to animals in the Town of Stratford.

B. For the purpose of implementing and enforcing such rules and regulations, the town board may impose such restrictions, limitations and conditions as the town board may deem appropriate.

SECTION 6: ENFORCEMENT

The Fulton County Sheriff's Department and/or any other police officer and/or other peace officer may enforce the provisions of this local law.

SECTION 7: PENALTIES

Any person, firm or corporation violating or permitting the violation of any provision of this local law shall be guilty of an offense and shall be subject to a fine of not less than \$25.00 nor more than \$100.00.

SECTION 8: VALIDITY

If any clause, sentence or provision of this local law shall be adjudged by a court of competent jurisdiction to be invalid, the invalidity thereof shall not affect, impair or invalidate the remainder of this local law.

SECTION 9: EFFECTIVE DATE

This local law shall become effective immediately upon its posting and filing thereof as provided by law.
