The highway department is gearing up for summer work. The plows and wings have been painted; we will be taking them off next week.

Work continues on the sweeper. We did start the rebuilt motor; it is leaking oil from the crank seal. The new seal will be here 4/11/2024. I am hopeful that the machine will be in working order once that is installed.

We are doing in season prep work for the summer equipment.

Truck 8 has an oil pressure problem it looks like it is an electrical problem. It is at Winkler's repair.

I had a pre-construction meeting with Carver and Andy for the Voorhees Road Project. Carver wants the poles moved prior to them starting work. I spoke with National Grid, and we are back on their schedule with them planning on moving the poles the week of the 22<sup>nd</sup>. We will build the access National Grid requires next week.

I have to file my requirement for next seasons salt by the end of the month. This season the number was 375 Ton. I would like 450 Ton for next season. At the price we are paying, NYS OGS Contract price the current budgeted amount will cover it. No increase in that budget line would be needed.
